Bevis receives Librarian of the Year, Excellence in Mentoring awards

Mary Bevis, Professor and Serials and Acquisitions Librarian, received multiple honors at this year's Alabama Library Association annual convention held in Florence. A Library employee since 1975, Ms. Bevis began her career as a Technical Services Assistant. She holds a B.S. in Business Administration and Economics, received her M.S. in Instructional Media from JSU in 1982, and was later hired as the Serials Librarian. She went on to receive an Ed.S. from the University of Alabama in 1989 and took on additional duties when the serials and acquisitions departments were combined.

Beta Phi Mu, the international library science honor society, selected Ms. Bevis to receive its prestigious Librarian of the Year award. The award is given in recognition of a librarian who is an outstanding leader in the profession and who has made significant contributions to the field of librarianship in Alabama. Ms. Bevis, who was nominated for the award by her colleagues at JSU, is known for her dedication to the field and her consistently demonstrated professionalism. Ms. Bevis has served in leadership positions in various professional organizations and continues to be an active member of the College, University, and Special Libraries Division of ALLA, the Technical Services and Systems Round Table, the Network of Alabama Academic Libraries, and the Alabama Association of College and Research Libraries. In addition to her impressive service contributions, Ms. Bevis has also made significant contributions to scholarly research in the field of librarianship, as her articles in various scholarly journals, including the prestigious *Journal of Academic Librarianship*, attest. Ms. Bevis's colleagues at JSU and within the profession describe her as patient, encouraging, helpful, kind, and extremely knowledgeable. Her willingness to encourage and share her knowledge with others led to her also being awarded the New Members Round Table Excellence in Mentoring award. This award is given to a librarian who has proved to be an exceptional mentor to junior librarians and those considering librarianship as a career. Ms. Bevis's wisdom, approachability, and professional demeanor guarantee not only that she is esteemed and respected by all her colleagues, but that established as well as new librarians frequently seek out her advice and guidance.

Ms. Bevis was presented with the Librarian of the Year award in front of a large audience at the ALLA convention President's Reception. She received the Excellence in Mentoring award at the ALLA convention New Members Round Table program on the importance of mentoring. ❖

Publications & Presentations

As usual, the librarians of the Houston Cole Library were busy this quarter publishing and presenting papers as part of their scholarly duties as tenure-track faculty members here at JSU.

Ms. Hanrong Wang co-authored "Cultural Adjustments for International Students in the Houston Cole Library: A Case Study" which was published in *The International Journal of Knowledge, Culture & Change*. Her research paper, co-authored with Ms. Jodi Poe, entitled "Integrating Resources and Services into Distance Education Courses" was presented at the 2006 US-China Forum on Distance Learning held in Troy, Alabama.

Mr. John-Bauer Graham, Ms. Bethany Skaggs, and Ms. Kim Stevens published "Digitizing a Gap: A Case Study in the History of a Statewide Repository Project and an Increase in Liaison Activity for one Medium-Sized Academic Library" in *Reference Services Review*, v.33 no. 3 (2005): 337-345. Ms. Skaggs also published "Assessing an Integrated Government Documents Collection" in *Collection Building*, v.25 no.1 (January 2006): 14-18 and a column, "NextGen: Happily (Mostly) Ever After" in *Library Journal*, v.131 no.1 (January 2006): 66. In addition, Ms. Skaggs and Ms. Stevens presented at the Alabama Library Association annual convention in Florence. Ms. Skaggs and Ms. Stevens presentation, entitled "Mentoring Relationships in an Academic Library" was given at the New Members Round Table program on the importance of mentoring, planned by Ms. Laurie Charnigo. Ms. Skaggs and Ms. Stevens were also members of a panel on tenure and promotion issues in the southeast which presented at the Tennessee Library Association (TLA)/Southeastern Library Association (SELA) joint conference in Memphis, Tennessee. Also at the TLA/SELA conference, Mr. Graham and Ms. Poe presented the New Voices Program "Interactive CD-ROMs for Library Instruction" and also presented "So you want to be an Academic Librarian" for the University of Alabama School of Library and Information Studies, Student Chapter of the American Library Association meeting. In addition, Ms. Poe regularly publishes the "Tech Notes" column in *The Alabama Librarian*.

As Chair of the Network of Alabama Academic Libraries Resource Sharing Committee, Ms. McAbee was a panelist in the "Rethinking Resource Sharing in Alabama" program presented at the College, University, & Special Libraries Division of the Alabama Library Association annual convention. Ms. McAbee reported on a statewide initiative to expand resource sharing among the Network of Alabama Academic Libraries. Recent protocol standards enable the various libraries to communicate bibliographic and patron information across platforms.
